Duration

The B.A programme is of 3 years' duration, divided into 6 semesters, with each semester focusing on core subjects along with electives, projects, and skill enhancement modules.

6. Procedure for Admission, Curriculum, Transaction and Evaluation

6.1 Eligibility

The minimum qualification for admission to the BA Programme is a pass in the 10+2 examination (any stream) from a recognized Board.

6.2 Programme Fees

The applicable fee for the B.A (Open and Distance Learning / Online Learning Programme) is Rs. 12,500 per semester (Rs. 25,000 per year). Fees may be paid through UPI, Demand Draft, or Cheque at the time of admission.

6.3 Registration Fees

At the time of application, students are required to pay Rs. 3,000/- (processing charges) via UPI, Demand Draft along with the Application Form and relevant documents (certificates/mark sheets).

Evaluation Methodology:

The evaluation of the BBA program would be based on Continuous Assessment and End Term Examination. Continuous Assessment would consist of 30% of the marks (30 marks) and Term-End Examination would consist of remaining 70% marks (70 marks). Detailed Evaluation scheme is as follows:
